Over 20 additional sessions will be delivered by firearm industry professionals, attorneys and technologists. Content will include a range of topics, such as: Firearm and Ammunition Excise Tax, Firearm Distribution in 2022, Mastering ATF Inspections, Cybersecurity and Data Protection, Retail POS Technology, Intellectual Property, Employment Law, Firearms Marketing, ATF Imports and more.
